Curriculum Lead Maths

Main Purpose of the Role

As the Curriculum Lead for Maths at In Toto Ed, you will take on a pivotal role in shaping and leading the maths curriculum across Key Stage 3, 4, and the post-16 programmes. Your primary focus will be to ensure that the maths curriculum is well-planned, sequenced, and relevant, meeting the needs of all students and aligning with the school's vision and values of providing a high-quality, inclusive education.

Key Responsibilities and Duties

Leading the Maths Curriculum

- Design, develop, and regularly review the vision, aims, and purpose for the maths curriculum, ensuring it is well-planned, sequenced, and relevant to the needs of all students
- Maintain the maths curriculum over time, amending it as required to reflect national and international developments
- Liaise with other teachers and senior leaders to develop and implement the maths curriculum effectively
- Ensure the maths curriculum meets the requirements of the National Curriculum and is implemented consistently across the school
- Establish and manage an appropriate system for assessing progress to measure the impact of the maths curriculum on students' learning
- Take an overarching responsibility for students' achievement and standards in maths
- Ensure the maths curriculum is ready for In Toto Ed schools to register with Ofsted as an Independent Special School

Leading and Managing Staff

- Hold regular team meetings with maths teachers to keep them informed of developments and changes in the maths curriculum
- Provide support to staff regarding teaching and learning, resources, and planning in maths
- Monitor the implementation and delivery of the maths curriculum through lesson observations, book looks, learning walks and student voice
- Provide feedback to staff to identify training needs and deliver continuing professional development (CPD) in maths
- Coach and model effective teaching practises in maths
- Support teachers in making accurate assessments, managing internal and external moderation, and completing external moderation exercises

Efficient and Effective Deployment of Resources

- Provide support with textbooks, online resources, TTRS, MyiMaths, Firefly (VLE) and other resources to ensure they align with the maths curriculum
- Audit, check, and manage maths resources to ensure they are up to date and match student and curriculum needs
- Manage the maths budget effectively to ensure resources add value and enhance the learning experience
- Prepare appropriate resources for remote learning to ensure the maths curriculum can be delivered to any students who are unable to attend In Toto Ed for face-to-face lessons

Additional Responsibilities

- Contribute to the school's self-evaluation on the effectiveness of the maths curriculum, its intent, implementation, and impact
- Present to staff, senior leaders and parents (if required) on the maths curriculum
- Provide cover in the unforeseen circumstance that another teacher is unable to teach
